## Conditions of Participation

1. In these conditions the term "Exhibitor" means the signatory of the Registration Contract, and includes all employees or agents of such and the term "Exhibition" means that described on the reverse hereof. "The Organisers" means Silver Star Corporation L.L.C.
2. In case of joint venture howsoever described, the Exhibitor is deemed to have obtained the consent of all the individual participants to all the conditions of this contract.
3. If the Exhibitor does not pay the balance of the contract amount at the prescribed time, the Organizer reserves the right after due notice to the Exhibitor or the agents as appropriate to cancel the booking. In this event, or if the Exhibitor cancels the booking after the application is granted, the deposit will be forfeited. Additionally, if cancellation occurs for either reason after the prescribed date for payment of the balance of the contract amount, a sum in liquidated damages equivalent thereto will be payable by the Exhibitor to the Organizer in any event.
4. Application for space must contain details of the proposed exhibits and the name of any other company represented by the Exhibitor whose products are to be shown or whose services are to be referred to on the stand. The charge for space is exclusive of any applicable federal or local Government or Municipal taxes all of which if any must be borne by the Exhibitor. Currently no such taxes are levied except income tax.
5. The Organizer shall have full power to determine in every respect the allocation of area and position of space and it shall be entitled for any reason which in its sole opinion is in the general interest of the Exhibition to vary the general layout or the situation and area of any particular stand even if already allocated and the Exhibitor shall accept a new allotment of space in substitution of that originally allotted.
6. Upon the acceptance of the Application for space a contract shall arise between the Organizer and the Exhibitor in the terms of these conditions subject to variation as mentioned and as regards space allotted the relationship of licensor and licensee shall immediately arise and continue between the Organizer and the Exhibitor. In case of non-payment of any sum due or any breach or non-observance of any of these conditions by the Exhibitor, the Organizer shall have the full right to revoke this license and to re-enter upon the allotted space and may remove and exclude the Exhibitor without prejudice to recovering all amounts payable hereunder, all other claims against the Exhibitors and the right to recover damages sustained by the Organizer.
7. The Exhibitor shall occupy the space allotted to it by 8 a.m. on the day prior to the opening of the Exhibition. In the event of default due to any cause whatsoever, the Exhibitor shall pay to the Organizer a further sum in liquidated damages equal to the total charge of the space and the Organizer shall have the right to deal with the space in any way it thinks best.
8. In the event of any Exhibitor committing an act of bankruptcy or if a limited company being wound up the contract with it shall be determined void and all amounts already paid shall be retained by the Organizer.
9. The Exhibitor may not assign, sublet or grant licences in respect of any part of the space allotted to it nor may advertisements of firms who are not bonafide exhibitors show on its stand. Only those products, services and companies mentioned on the Registration contract may be incorporated in the stand.
10. Breach of Contract and Withdrawal by the Exhibitor: Without prejudice to the rights and remedies of the organizer in respect of any breach of the Contract on the part of the Exhibitor, the Organizer may at its discretion allow the exhibitor to withdraw from the Exhibition subject to the following conditions:
  - A. The Exhibitor must give written notice to the Organizer that he desires to withdraw and if the Organizer allows such withdrawal it will notify the Exhibitor of its decision in writing;
  - B. Any such notification by the Organizer to the Exhibitor will constitute a cancellation of the Contract subject to the payment by the Exhibitor to the Organizer of a consideration for release from the Contract;
  - C. The amount of such payment will be specified in the Organizer's notification to the Exhibitor and will be that proportion of the space rental payable under the Contract dependent upon the date upon which the Organizer receives the notification from the Exhibitor as detailed below:

Notice of Withdrawal Received by Organizer

i. On or before 1st September 2016	: 50% of space rent payable
ii. After 1st September 2016	: 100% space rent payable
11. The Exhibitor will be totally responsible for the cost of restoring to its original condition any part of the stand or structure occupied by it which has been altered or damaged in any way.
12. In the event of the Exhibition premises or any part or stand thereof or any facility or service pertaining to the Exhibition being unavailable as a result of fire, flood, tempest or any other cause or as a result of government intervention, strike, lockouts, labour disputes, riot or any other case or agency over which the Organizer decide that owing to any such cause or agency it is necessary or advisable to cancel, postpone or resite the Exhibition, the Organisers shall not be liable to indemnify or reimburse the Exhibitor in respect of any damage or loss, direct or indirect arising as a result thereof.
13. In no event shall the Exhibitor have any claim for damages of any kind against the Organizer in respect of any loss or damage consequent upon the prevention or postponement or abandonment of the Exhibition by reason of the happening of any of the events referred to in Condition 12 or otherwise or of the Hall becoming wholly or partially unavailable for the holding of the Exhibition for reason beyond the Organizer's control and the Organizer shall be entitled to retain all sums paid by the Exhibitor or such part thereof as the Organizer shall consider necessary. If in the opinion of the Organizer by re-arrangement or postponement of the period of the Exhibition or by substitution of another hall, or building or in any other reasonable manner, the Exhibition can be carried out these Conditions shall be binding upon the parties except as to size and position as to which any modification or rearrangement shall be determined by the Organizer.
14. The Exhibitor shall hold the Organizer safe and harmless from all loss or damage suffered by or arising out of any act or default of any servant agent employee or subcontractor of the Exhibitor.
15. The Organizer reserves the right to alter, add to, or amend any of these Conditions and the decision of the Organizer shall be final.
16. The Exhibitor shall not without the written consent of the Organizer display, exhibit or bring into the Hall any explosives or dangerous material or any such thing which cause noxious fumes or which make use of or display any other materials which may involve a danger to the health or safety of any person. The Exhibitor shall indemnify the Organizer against any loss or damage arising out of a breach of this clause.
17. The Organizer will issue necessary informations from time to time to the Exhibitor containing detailed instructions for the smooth organisation of the Exhibition.
18. The Organizer cannot accept any complaint or claim against it unless it is submitted in writing to the address given below within two weeks of the closing date of the Exhibition. All claims and disputes shall be settled in Muscat in accordance with Laws of the Sultanate of Oman.
19. All display advertising exhibits and stand arrangements shall be appropriate to the subject matter of the Exhibition in the sole opinion of the Organizer and shall be tasteful and of a suitably high standard and shall not contravene or conflict with any local law, moral or custom and if in the opinion of the Organizer, the Exhibitor is in breach of this clause, the Organizer may direct the Exhibitor to rectify such breach and the Exhibitor shall immediately act accordingly.
20. In the event of a breach of any of the conditions herein the Organizer may in all cases retain all amounts paid by the Exhibitor and recover further amounts from the Exhibitor as provided herein.
21. Stand rentals may be paid in U.S. Dollars or Rials Omani. The Exhibitor is liable for making good any exchange losses to the Organizer at the time of conversion into Rials Omani. All communications to be addressed to :
